



Announcement from Chulalongkorn University
Admission to the Bachelor of Arts in Economics (International Program)
Faculty of Economics
For the Academic Year 2024 (Admission - Second Round)

The Chulalongkorn University has authorized the Bachelor of Arts in Economics (International Program), Faculty of Economics, to select applicants for the Academic Year 2024 (Early Admission).

1. Qualification of Applicants

Applicants must have completed or presently be enrolled in their final year of high school, or the equivalent both in the kingdom of Thailand and foreign country.

1.1. Applicants must submit all of the following three required documents and meet all three requirements.

1.1.1. Transcript of high school or the equivalent with a minimum GPA of 2.75. In the case of an applicant with more than one high school record, adhere to the school that provides the applicant with a graduation certificate.

1.1.2. One of the following English proficiency test scores:

Applicants who wish to apply by using both parts of SAT (Evidence-Based Reading & Writing and Math) or ACT (English & Reading and Math) or CU-AAT (Verbal and Math) must submit the scores of both parts from the same test occasion.

The official score report of the tests in 1.1.2 and 1.1.3 is valid only if the tests were taken no more than two years prior to the application deadline.

1.2. Applicants must have a history of good behavior and agree to abide strictly by existing and any future University regulations, codes and policies.

If there is evidence shown later that the applicant does not meet the requirements or gave false information, the application will be rejected whether or not an offer has already been made. In addition, the applicant may be prosecuted, according to law.

2. Number of Admitted Applicants

The Bachelor of Arts in Economics (International program), Faculty of Economics, is authorized to admit up to 10 qualified applicants.

4. Application Procedure and Packet

4.1 Application Procedure

Qualified applicants who meet the requirements in step 1 must apply online via the application system provided by the Bachelor of Arts Program in Economics between February 21 and March 27, 2024, as follows:

- 4.1.1 Enter data online through the website <http://www.eba.econ.chula.ac.th/Admission>
- 4.1.2 Applicants are required to upload the necessary documents, duly certified with notarized signatures as specified in item 4.2 (in .pdf format) through the system.
- 4.1.3 The applicants upload the proof of fee payment in the system. The application fee payment of non-refundable 1,500 baht can be made to Siam Commercial Bank, account number 468-022701-8, account name “Faculty of Economics, Chulalongkorn University” or via Digital Banking of Siam Commercial Bank (SCB Easy or SCB ATM) Bill Payment No. 468-022701-8, Reference No. (Ref. 1) 4088. The form can be downloaded at <http://www.eba.econ.chula.ac.th/Admission>. The application fee is non-refundable under any circumstance.
- 4.1.4 **Applicants are required to check all required documents before submitting the application form. The application will not be able to edit the application once it has been submitted.**

Applicants are responsible and are held accountable to check if they meet all requirements according to the admission announcement. If there are any mistakes incurred by the applicants or application packets do not meet desirable qualifications, the applicants will be disqualified.

4.2 Application Required Documents

Applicants must upload the required documents as follows:

- 4.2.1 A certified copy of high school diploma and official transcript. In case that applicants' institution does not provide the official transcript based on the 4.0 scale system, the applicants must request GPAX equivalence certificate from Chulalongkorn University Academic Testing Center via <https://hscs.atc.chula.ac.th/> and upload the certificate in the system.
- 4.2.2 A certified copy of the enrollment certificate (for applicants presently enrolled in their final year of high school) should be no more than 6 months old, counting from the last day of the application period or as indicated on the document to ensure it is not outdated. (With a notarized signature)
- 4.2.3 One certified copy of identification card for Thai citizen or one certified copy of passport for non-Thai citizen. (With a notarized signature)
- 4.2.4 One certified copy of name/surname change certificate (if any) (With a notarized signature)
- 4.2.5 One digital colored photograph 1 inch in white background (full-faced with no teeth showing view directly facing the camera in student uniform or polite attire taken not older than 6 months. Hat and sunglasses are not allowed.)
- 4.2.6 Exam results of English proficiency test scores according to item 1.1.2
 - 4.2.6.1 If an applicant selects the IELTS exam, the result must be sent by its testing center directly to the Bachelor of Arts in Economics (International Program). Please use the code for **Chulalongkorn University-EBA Program Faculty of Economics**.
 - 4.2.6.2 If an applicant selects the TOEFL, the result must be sent by ETS directly to the Bachelor of Arts in Economics (International Program). Please use the code for **Chulalongkorn EBA Program C886**.
 - 4.2.6.3 If an applicant selects the SAT, the result must be sent by College Board directly to the Bachelor of Arts in Economics (International Program). Please use the code for **Chulalongkorn EBA Program 9080**.
 - 4.2.6.4 If an applicant selects the Duolingo English Test exam, the result must be sent by the test center to the Bachelor of Arts in Economics (International Program). Please use the code for **Chulalongkorn University-EBA Program Faculty of Economics**.
 - 4.2.6.5 If an applicant selects the ACT exam, the result must be sent by the test center to the Bachelor of Arts in Economics (International Program). Please use the code for **CHULALONGKORN UNIV EBA PRGM 8011**.
 - 4.2.6.6 If an applicant selects the CU-TEP or CU-AAT (Verbal) exam, the original score report issued by Chulalongkorn University Academic Testing Center must be submitted. The score report can be obtained at Chulalongkorn University Academic Testing Center, 3rd floor Chamchuri 8 building.

4.2.7 Exam results of Mathematics test scores according to item 1.1.3

4.2.7.1 If an applicant selects SAT, the result must be sent by College Board directly to the Bachelor of Arts in Economics (International Program). Please use the code for **Chulalongkorn EBA Program 9080**.

4.2.7.2 If an applicant selects the ACT exam, the result must be sent by the test center to the Bachelor of Arts in Economics (International Program). Please use the code for **CHULALONGKORN UNIV EBA PRGM 8011**.

4.2.7.3 If an applicant selects the A-Level (Math) or IB (Math HL), please submit the certified copy of A-Level (Math) or IB (Math HL) score report.

4.2.7.4 If an applicant selects the CU-AAT (Math) exam, the original score report issued by Chulalongkorn University Academic Testing Center must be submitted. The score report can be obtained at Chulalongkorn University Academic Testing Center, 3rd floor Chamchuri 8 building.

Remarks: Applicants must submit the electronic test results from 4.2.6.1-4.2.6.5 and 4.2.7.1-4.2.7.2 before applying to the EBA online admission system.

4.2.8 Proof of application fee payment by providing pay-in slip with official SCB stamp (printed from <http://www.eba.econ.chula.ac.th/Admission> in item 4.1.3), or proof of payment via online banking (SCB Easy), or transfer slip for SCT ATM.

The applicants must submit all documents in the applicant packet. An incomplete application packet will not be considered.

Applications will only be considered if applicants submit all required documents. The application fee is non-refundable once the application form has been submitted.

5 Selection Criteria

5.1 Evaluation Criteria for Interview Shortlist

Eligible applicants for the interview will be evaluated on the basis of all three requirements and documents on the basis of requirement 4.2.

5.2 Interview Shortlist Announcement

Only shortlisted applicants for interview will be announced based on overall scores according to item 4.2.5 and 4.2.6 on **April 4, 2024** at the website <http://www.eba.econ.chula.ac.th/Admission>. Details of interview will be included in the announcement.

The announced number of applicants shortlisted for interview may be greater than the intended number of students to be admitted to the program due to the expectation that some applicants may not attend the interview session or may fail to confirm their enrollment in the program within the specified time period.

5.3 Interview

Interviews for the eligible applicants will be held on **April 9-12, 2024 at the Faculty of Economics, Chulalongkorn University**. Those who fail to interview will be considered as waiving their rights for admission to the program.

5.4 Evaluation Criteria

Eligible applicants will be evaluated on the basis of all three requirements in item 4.2 and the interview scores. The weights assigned are as follows:

5.4.1	English proficiency test score	35 %
5.4.2	Mathematics test score	35 %
5.4.3	Interview	30 %

5.5 Preliminary Selection Announcement

The Faculty will announce a list of preliminary selected applicants on **April 19, 2024** on the website <http://www.eba.econ.chula.ac.th/Admission>.

List of preliminary selected applicants will be announced according to or more than the number on the announcement in case that the last selected applicant has same scores.

5.6 Preliminary enrollment Confirmation

Preliminary selected applicants must report their enrollment on **April 22, 2024, during 08:00-12:00 hrs., at the website <http://www.eba.econ.chula.ac.th/Admission>**. Applicants who fail to report will be considered as waiving their rights for admission to the program. **The faculty will announce additional preliminary selected applicants on April 23, 2024, 12:00 hrs.** and the additional preliminary selected applicants must report their enrollment on **April 24, 2024, during 08:00-12:00 hrs., at the website <http://www.eba.econ.chula.ac.th/Admission>** (if any). The Faculty of Economics will not announce any additional preliminary selected applicants in any case.

5.7 Announcement of Selected Applicants

The faculty will announce the list of selected applicants on **April 30, 2024 at the website <http://www.eba.econ.chula.ac.th/Admission>**.

5.8 Enrollment confirmation through TCAS67

Selected applicants must confirm the enrollment through TCAS67 system during **May 2-3, 2024 on the website <http://student.mycas.com>**. Applicants who failed to confirm the enrollment will be considered as waiving their rights for admission for this round.

The Faculty of Economics will not announce any additional selected applicants in any case.

5.9 Enrollment declining through TCAS67

The selected applicants who already performed the online confirmation through the TCAS67 system during **May 2-3, 2024**, but wish to decline the right to enroll in the program, could do so through the TCAS67 system on **May 4, 2024** on the website <http://student.mycas.com>.

5.10 Enrollment confirmation with payment

The Faculty of Economics will announce the list of confirmed applicants from the TCAS67 system in the first round on **May 10, 2024 at the website <http://www.eba.econ.chula.ac.th/Admission>**.

Accepted applicants must report their enrollment and provide proof of the confirmation fee payment on **May 13, 2024, during 09:00-1200 hrs. at the website <http://www.eba.econ.chula.ac.th/Admission>**. Accepted applicants who failed to report the enrollment and pay the confirmation fee will be considered as waiving their rights for admission for this round. The Pay-in Form can be downloaded at <http://www.eba.econ.chula.ac.th/Admission>. **The confirmation fee is non-refundable.**

An official copy of their high school diploma or the equivalent must be submitted at the same time. If the issuance of the diploma or the equivalent is being processed, the complete official copy must be submitted to the EBA office by July 31, 2024.

5.11 Final acceptance announcement

Chulalongkorn University will announce a list of eligible candidates on May 20, 2024 **at the website** <http://www.eba.econ.chula.ac.th/Admission>.

The Office Committee's acceptance result is final.

6. Enrollment Conditions

6.1 To be eligible for initial enrollment as a Chulalongkorn University student, enrollees must have completed a high school degree or its equivalent. If the University subsequently discovers that the applicants have not in fact graduated or have failed to fulfill any of the admission criteria, the eligibility of the applicant for enrollment shall be revoked and Chulalongkorn University reserves the right to not refund the application fee, the confirmation fee, and the tuition fee under any circumstances.

Graduates of international schools in Thailand or overseas institutions which are not accredited by the Ministry of Education must possess an Equivalency Certification issued by Chulalongkorn University.

6.2 If there is evidence of any falsification of documents, forgery, or fraud in registration, the student's status will be terminated and may be prosecuted according to Thai law.

6.3 If the University subsequently discovers that an applicant performed the confirmation through the TCAS67 system for more than one program, their right to study will be rescinded without prior notice.

7. Tuition fees and special tuition fees

Tuition fees and special tuition fees are charged in accordance with the announcement of Chulalongkorn University.

High School Provisional/Equivalency Certificate and GPAX Equivalency Certificate

High School Equivalency Certificate

For applicants already graduated from a foreign high school or an international school in Thailand which is not accredited by the Thai Ministry of Education, applicants will need to obtain an equivalency certification via website <https://hsc.es.atc.chula.ac.th> before applying to the program. **This includes applicants applying with GED, A-level, Cambridge Pre-U, IB, NZQA, or other qualifications from abroad.**

The process will be completed within 7 working days after payment confirmed.

High School Provisional Equivalency Certificate

For applicants currently attending a foreign high school or an international school in Thailand which is not accredited by the Thai Ministry of Education, applicants will need to obtain a provisional equivalency certification via website <https://hsc.es.atc.chula.ac.th> before applying to the program. **This includes applicants applying with GED, A-level, Cambridge Pre-U, IB, NZQA, or other qualifications from abroad.**

The process will be completed within 3 working days after payment confirmed.

High School GPAX Equivalency Certificate

For applicants **who would like to convert their GPAX to 4.0 system**, applicants will need to obtain a GPAX equivalency certificate via website <https://hsc.es.atc.chula.ac.th> before applying to the EBA program. **This includes applicants applying with GED, A-level, Cambridge Pre-U, IB, NZQA, or other qualifications from abroad.**

The process will be completed within 7 working days after payment confirmed.
