

Announcement from Chulalongkorn University Admission to the Bachelor of Arts in Economics (International Program) Faculty of Economics

For the Academic Year 2026 (Early Admission - First Round)

The Chulalongkorn University has authorized the Bachelor of Arts in Economics (International Program), Faculty of Economics, to select applicants for the Academic Year 2026 (Early Admission).

1. Qualification of Applicants

IELTS

1.1.3.

Applicants must have completed or presently be enrolled in their final year of high school, or the equivalent either in the kingdom of Thailand or foreign country.

- 1.1. Applicants must submit all of the following three required documents and meet all three requirements.
 - 1.1.1. Transcript of high school or the equivalent with a minimum GPA of 3.00. In the case of an applicant with more than one high school record, adhere to the school that provides the applicant with a graduation certificate.

Applicants who wish to apply by using both parts of SAT (Evidence-Based Reading & Writing and Math) or ACT (English & Reading and Math) or CU-AAT (Verbal and Math) must submit the scores of both parts from the same test occasion.

The official score report of the tests in 1.1.2 and 1.1.3 is valid only if the tests were taken no more than two years prior to the application deadline.

1.2. Applicants must have a history of good behavior and agree to abide strictly by existing and any future University regulations, codes and policies.

If there is evidence shown later that the applicant does not meet the requirements or gave false information, the application will be rejected whether or not an offer has already been made. In addition, the applicant may be prosecuted, according to law.

2. Number of Admitted Applicants

The Bachelor of Arts in Economics (International program), Faculty of Economics, is authorized to admit up to 140 qualified applicants.

In case that there are less than 140 students in this first round, the remaining slots will be added in the second round admission as approved by the Faculty.

4. Application Procedure and Packet

4.1 Application Procedure

Qualified applicants who meet the requirements in step 1 must apply online via the application system provided by the Bachelor of Arts Program in Economics between November 27 and December 26, 2025, as follows:

- 4.1.1 Enter data online through the website https://admission.eba.econ.chula.ac.th.
- 4.1.2 Applicants are required to upload the necessary documents, duly certified with notarized signatures as specified in item 4.2 (in .pdf format) through the system.
- 4.1.3 Applicants are required to pay an application fee of 1,500 THB (One thousand five hundred Baht) through the payment system of the Office of Financial Affairs, Accounting, and Procurement at Chulalongkorn University via the website https://ofas.chula.ac.th/Service. Select "Faculty of Economics" and then choose "EBA application fee AY 2026 (Early Admission Round)". After that, click on the "Pay" button. Once on the payment page, follow these steps:
 - **Step 1:** The screen will display the application fee details for the Academic Year 2569 (2026) Early Admission Round, with a payment amount of 1,500 THB. Click on the "Next" button to proceed to the next step.
 - Step 2: Enter the payer's information/receipt details (only in Thai or English).
 - **Step 3:** Choose a payment method. You can choose between the following two options:
 - Bank transfer (QR Payment)
 - Credit/debit card (with a service fee as specified)

Once you have selected your payment method, click on the "Pay" button. The screen will display the payment details. Click on the "Make payment" button to proceed with the payment.

Note:

- Please do not close or refresh the page while the transaction is in progress. The payment confirmation should appear within 30 seconds. If no confirmation is shown, click "Check status."
- The payment receipt will be sent to the email address provided by the payer. If the payment is made via QR Code after 22:59 or via credit card after 20:59, the receipt will be issued the following day.
- The payment system will close on December 26, 2025, at 23:00.
- 4.1.4 Applicants are required to check all required documents before submitting the application form. The application will not be able to edit the application once it has been submitted.

Applicants are responsible for ensuring they meet the announced eligibility criteria and that all provided information, and documents are truthful and accurate. If any errors, discrepancies, or failures to meet the requirements are discovered at any stage of the application process, the applicant will be immediately disqualified from the selection process.

4.2 Application Required Documents

Applicants must upload the required documents as follows:

4.2.1 A 1-inch photograph (1 copy)

A recent front-facing photo (taken within the past 6 months) showing the applicant's full face clearly, wearing a school uniform or formal attire. The applicant must not wear a hat or sunglasses, should not smile with teeth visible, and the background should be plain.

4.2.2 High School Transcript

In case the applicant's high school does not use a 0.00–4.00 GPA scale, the applicant must request a GPAX equivalency certificate issued by the Council of University Presidents of Thailand (CUPT) via https://hsces.atc.chula.ac.th/.

The document must clearly specify that it is for the Bachelor of Arts in Economics (International Program), Faculty of Economics, Chulalongkorn University only.

- 4.2.2.1 For current students Applicants who are still studying must upload:
 - A **copy of the current transcript** showing grades up to the latest completed semester.

For schools abroad that are **not accredited by the Ministry of Education**, applicants must request an **academic equivalency certificate** issued by the CUPT at https://hsces.atc.chula.ac.th/, stating that it is **for the Bachelor of Arts in Economics** (International Program), Faculty of Economics, Chulalongkorn University only.

(The applicant must sign to certify the copy as true.)

A certificate of student status from the current institution.

This certificate must still be valid or must have been issued within the past 6 months (if no expiry date is stated), counted up to the final date of application submission.

- 4.2.2.1 For graduates Applicants who have already graduated must upload:
 - A copy of the complete transcript showing the date of graduation. (The applicant must sign to certify the copy as true.)
 - A copy of the graduation certificate.

For schools abroad that are **not accredited by the Ministry of Education**, applicants must request an **academic equivalency certificate** issued by the CUPT at https://hsces.atc.chula.ac.th/, specifying that it is **for the Bachelor of Arts in Economics (International Program)**, Faculty of Economics, Chulalongkorn University only.

(The applicant must sign to certify the copy as true.)

- 4.2.3 One certified copy of identification card for Thai citizen or one certified copy of passport for non-Thai citizen. (With a notarized signature)
- 4.2.4 One certified copy of name/surname change certificate (if any) (With a notarized signature)
- 4.2.5 Exam results of English proficiency test scores and Mathematics test scores according to item 1.1.2 and 1.1.3

For applicants submitting test scores from IELTS, TOEFL, SAT, ACT, or the Duolingo English Test: You must request the testing agency to send the official electronic test scores directly to the Bachelor of Arts in Economics (International Program) before applying to the EBA online admission system as per the details provided below. Additionally, please upload a .pdf file of the test score report through the online application system.

- 4.2.5.1 If an applicant selects the IELTS exam, the result must be sent by its testing center directly to the Bachelor of Arts in Economics (International Program). Please use the code for Chulalongkorn University-EBA Program Faculty of Economics.
- 4.2.5.2 If an applicant selects the TOEFL, the result must be sent by ETS directly to the Bachelor of Arts in Economics (International Program). Please use the code for <u>Chulalongkorn EBA Program C886</u>.
- 4.2.5.3 If an applicant selects the SAT, the result must be sent by College Board directly to the Bachelor of Arts in Economics (International Program). Please use the code for Chulalongkorn EBA Program 9080.
- 4.2.5.4 If an applicant selects the Duolingo English Test exam, the result must be sent by the test center to the Bachelor of Arts in Economics (International Program). Please use the code for <u>Chulalongkorn University EBA Program, Faculty of Economics</u>.
- 4.2.5.5 If an applicant selects the ACT exam, the result must be sent by the test center to the Bachelor of Arts in Economics (International Program). Please use the code for CHULALONGKORN UNIV EBA PRGM 8011.
- 4.2.5.6 If an applicant selects the CU-TEP or CU-AAT exam, the original score report issued by Chulalongkorn University Academic Testing Center must be submitted. The score report can be obtained at Chulalongkorn University Academic Testing Center, 3rd floor Chamchuri 8 building.
- 4.2.5.7 If an applicant selects the A-Level (Math) or IB (Math HL), please submit the certified copy of A-Level (Math) or IB (Math HL) score report.
- 4.2.6 Proof of application fee payment by providing pay-in slip from https://admission.eba.econ.chula.ac.th/ in item 4.1.3

The applicants must submit all documents in the applicant packet. An incomplete application packet will not be considered.

Once the application has been successfully submitted through the designated system, the Faculty of Economics will not refund the application fee under any circumstances.

5 Selection Criteria

5.1 Evaluation Criteria for Interview Shortlist

Eligible applicants for the interview will be evaluated on the basis of all three requirements and documents on the basis of requirement 1.1.

5.2 Interview Shortlist Announcement

Only shortlisted applicants for interview will be announced based on overall scores according to item 1.1 on January 7, 2026 at the website https://admission.eba.econ.chula.ac.th. Details of interview will be included in the announcement.

The announced number of applicants shortlisted for interview may be greater than the intended number of students to be admitted to the program due to the expectation that some applicants may not attend the interview session or may fail to confirm their enrollment in the program within the specified time period.

5.3 Interview

Interviews for the eligible applicants will be held on January 10, 2026 at the Faculty of Economics, Chulalongkorn University. Those who fail to attend the interview will be considered to have waived their right for admission to the program.

5.4 Evaluation Criteria

The Faculty of Economics will consider the list of applicants who pass the interview based on the supporting documents and evidence specified in Section 4.2, as well as the interview scores assessed through an English interview conducted by the Bachelor of Arts in Economics (International Program), Faculty of Economics, Chulalongkorn University. The evaluation will be weighted as follows:

5.5 Preliminary Selection Announcement

The Faculty of Economics will announce a list of preliminary selected applicants on **January 16, 2026** on the website https://admission.eba.econ.chula.ac.th.

List of preliminary selected applicants will be announced according to or more than the number on the announcement in case that the last selected applicant has same scores.

5.6 Confirmation of Admission Offer through the CU International Program Clearing House System

Applicants who have been announced as successful interviewees for admission to Chulalongkorn University's international programs in the Early Admission Round are required to confirm their admission offer by selecting only one faculty/program/major through the CU International Program Clearing House system at the Center for Academic Testing's website: https://tcas.atc.chula.ac.th/inter.

Successful applicants (whether admitted or waiting-list candidates) may confirm only one offer. Once the confirmation has been made, withdrawal or change of faculty/program/major will not be permitted, and the applicant will no longer be eligible to claim any remaining offers from other programs. (For more details on the confirmation process via the CU International Program Clearing House system, please visit https://tcas.atc.chula.ac.th/inter) The process is as follows:

5.6.1 Confirmation of Admission Offer through the CU International Program Clearing House (Round 1)

Applicants who have been announced as admitted candidates following the interview are required to confirm their admission offer by selecting the faculty/program/major they wish to enroll in through the CU International Program Clearing House system at https://tcas.atc.chula.ac.th/inter on January 22, 2026, from 08:00 to 13:00 hrs. Failure to confirm the offer within the specified date and time will be regarded as a withdrawal of the admission offer.

The Faculty of Economics reserves the right to announce the names of waiting list candidates who are eligible to confirm their offer (additional Round 1) at https://admission.eba.econ.chula.ac.th/ on January 26, 2026, at 13:00 hrs. (if any). This opportunity applies only to candidates who have not yet exercised their right to confirm admission on January 22, 2026.

5.6.2 Confirmation of Admission Offer through the CU International Program Clearing House (Round 2, if any)

Applicants who have been announced as **waiting list candidates** eligible to confirm their admission offer (additional Round 1) are required to **confirm their admission offer** by selecting the faculty/program/major they wish to enroll in through the **CU International Program Clearing House system** at https://tcas.atc.chula.ac.th/inter on **January 27, 2026, from 08:00 to 13:00 hrs.** Failure to confirm the offer within the specified date and time will be regarded as a **withdrawal of the admission offer**.

The Faculty of Economics reserves the right to announce the names of additional waiting list candidates (Round 2) who are eligible to confirm their offer at https://admission.eba.econ.chula.ac.th/on January 29, 2026, at 13:00 hrs. (if any).

This opportunity applies only to candidates who have not yet exercised their right to confirm admission on January 22, 2026 or January 27, 2026.

5.6.3 Confirmation of Admission Offer through the CU International Program Clearing House (Round 3, if any)

Applicants who have been announced as waiting list candidates eligible to confirm their admission offer (additional Round 2) are required to confirm their admission offer by selecting the faculty/program/major they wish to enroll in through the CU International Program Clearing House system at https://tcas.atc.chula.ac.th/inter on January 30, 2026, from 08:00 to 13:00 hrs. Failure to confirm the offer within the specified date and time will be regarded as a withdrawal of the admission offer, and this will be considered the final stage of the selection process.

The Faculty of Economics will **not make any further announcements** or **call additional candidates from the remaining waiting list** after the confirmation day of the waiting list candidates (additional Round 2), **under any circumstances.**

5.7 Announcement of Selected Applicants

The faculty will announce the list of selected applicants on February 4, 2026 at the website https://admission.eba.econ.chula.ac.th/.

5.8 Enrollment confirmation through TCAS69

Selected applicants must confirm the enrollment through TCAS69 system during February 6-7, 2026 on the website http://student.mytcas.com. Applicants who failed to confirm the enrollment will be considered as waiving their rights for admission for this round.

In case that there are less than 140 students as announced in this round, the remaining slots will be added in the next round admission as approved by the faculty. The Faculty of Economics will not announce any additional selected applicants in any case.

5.9 Enrollment declining through TCAS69

The selected applicants who already performed the online confirmation through the TCAS69 system during February 6-7, 2026, but wish to decline the right to enroll in the program, could do so through the TCAS69 system on **February 8, 2026** on the website http://student.mytcas.com.

5.10 Announcement of TCAS69 Round 1 Confirmed Candidates

The Faculty of Economics will announce the list of confirmed applicants from the TCAS69 system in the first round on February 10, 2026 at the website https://admission.eba.econ.chula.ac.th/.

Accepted applicants must report their enrollment and provide proof of the confirmation fee payment on February 12, 2026, during 09:00-1200 hrs. at the website https://admission.eba.econ.chula.ac.th/. Accepted applicants who failed to report the enrollment and pay the confirmation fee will be considered as waiving their rights for admission for this round. The Pay-in Form can be downloaded at https://admission.eba.econ.chula.ac.th/. The confirmation fee is non-refundable.

An official copy of their high school diploma or the equivalent must be submitted at the same time. If the issuance of the diploma or the equivalent is being processed, the complete official copy must be submitted to the EBA office by July 31, 2026.

5.11 Final acceptance announcement

Chulalongkorn University will announce a list of eligible candidates on February 19, 2026 at the website https://admission.eba.econ.chula.ac.th/.

The Office Committee's acceptance result is final.

6. Enrollment Conditions

6.1 To be eligible for initial enrollment as a Chulalongkorn University student, enrollees must have completed a high school degree or its equivalent. If the University subsequently discovers that the applicants have not in fact graduated or have failed to fulfill any of the admission criteria, the eligibility of the applicant for enrollment shall be revoked and Chulalongkorn University reserves the right to not refund the application fee, the confirmation fee, and the tuition fee under any circumstances.

Graduates of international schools in Thailand or overseas institutions which are not accredited by the Ministry of Education must possess an Equivalency Certification issued by Chulalongkorn University.

- **6.2** If there is evidence of any falsification of documents, forgery, or fraud in registration, the student's status will be terminated and may be prosecuted according to Thai law.
- **6.3** If the University subsequently discovers that an applicant performed the confirmation through the TCAS69 system for more than one program, their right to study will be rescinded without prior notice.

7. Tuition fees and special tuition fees

Tuition fees and special tuition fees are charged in accordance with the announcement of Chulalongkorn University.
